- 5.4 Lyon JD 7 Lyon county is going through the process of redetermining ditches so that the buffers fall under 103E instead of 103F. They just wanted the watershed district to be aware of the process. Since this is just a redetermination and not an improvement, there is nothing in 103E that would require the watershed's involvement in the process.

The goals of the Yellow Medicine Watershed Partners are to: (1) mitigate altered hydrology and work to reduce the potential for flooding; (2) minimize the transport of excess nutrients, sediment, and bacteria into our surface waters; and (3) preserve and protect groundwater quantity and quality.
