### **Old Business**

4.1 Unpermitted work on Cottonwood Golf Course – Mr. Loe and representatives of the Golf Course Board (Kyle Boe spoke on behalf of the Board) attended the meeting to continue addressing their concerns to the WD Board.

Loe had submitted an engineer report to the office stating that the engineer conducted a desktop review of the project and that the drainage coefficient would fall under the .5 even with the 30" line. With that known, this is a project the District would have permitted had there been an agreement between the landowners.

The Golf Course would like to see the original 20" and 10" lines restored and for the ground to be completely restored. Mr. Loe believes that these are 24" and 15".

Since it is still not clear if the current easement gave Mr. Loe the ability to install the current 30" although it is clear and undisputed that he had the ability to repair the existing line. It is the Districts opinion at this point, that this is a private landowner dispute since the line would have been permitted.

Buysse moved to table the discussion until there is clarification of the easement or the parties come to an agreement. Briggs seconded. Motion passed unanimously.

The goals of the Yellow Medicine Watershed Partners are to: (1) mitigate altered hydrology and work to reduce the potential for flooding; (2) minimize the transport of excess nutrients, sediment, and bacteria into our surface waters; and (3) preserve and protect groundwater quantity and quality.
