- 5.1 1W1P Cost-share Policy It was recommended by the 1W1P Policy Committee to change the District cost-share policy to increase the amount that the District approves without presenting to the Policy Committee, from \$15,000 to \$30,000. The Policy also needs to reflect that the allowable amount of tile from a basin to an outlet is 3000 feet. Buysse moved to approved the changes. Volstad seconded. Motion passed unanimously.
- 5.2 Running Board Staff requested that we have running boards put on the truck for safety reasons. Volstad moved to approved the expense. Briggs seconded. Motion passed unanimously.
- 5.3 Biennial Summit/Annual Meeting Overholser requested that we start holding District update meetings every other year on opposite years of the 1W1P Biennial summit.
 Overholser also requested that the District pays for the meal for the Biennial Summit.

The goals of the Yellow Medicine Watershed Partners are to: (1) mitigate altered hydrology and work to reduce the potential for flooding; (2) minimize the transport of excess nutrients, sediment, and bacteria into our surface waters; and (3) preserve and protect groundwater quantity and quality.
