Old Business

4.1 Loe and Cottonwood Golf Course – Timm has spoken with Mr. Loe. He plans on abandoning the 30" line going through the Golf course and repairing the existing lines. There has been no new communication with the Golf Course representatives.

New Business

- 5.1 WD 8 Assessment Notice was received from Lincoln County that if the WD 8 assessment is paid in full by January 31st there will be no interest added. If it is not paid before that date then 4% interest will be charged. The district is going to look into this more and see how this would affect the individual landowners assessed into WD 8.
- 5.2 COLA Disscussion on what the COLA should be for 2022. This would go into effect Jan.
 1, 2022. The board took into concideration that the Social Security COLA for 2022 will be
 5.9% and that the federal government is giving a 4.9% COLA and 2.7% locality raise.
 After discussion, the board felt that with the current rate of inflation a 5% COLA raise for all employees seemed reasonable. Volstad moved to approve a 5% COLA for 2022.
 Briggs seconded. Motion passed unanimously.
